ORDER

On February 13, 2009, North Hopkins Water District ("North Hopkins") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹

The Commission, having reviewed the record and being sufficiently advised, finds that:

- 1. North Hopkins purchases water from the City of Madisonville ("Madisonville").
- 2. Madisonville notified North Hopkins that, effective with its March 8, 2009 billing, Madisonville's wholesale water rate to North Hopkins would increase from \$3.27 per 1,000 gallons to \$3.59 per 1,000 gallons. North Hopkins proposes to increase the water rates to its customers effective March 10, 2009.
- 3. During the 12 months ending December 31, 2008, North Hopkins purchased 79,267,000 gallons of water and sold 69,393,610 gallons. The increase in the cost of purchased water is \$25,365.44, resulting in a purchased water adjustment of \$0.37 per 1,000 gallons.

4. The purchased water adjustment of \$0.37 per 1,000 gallons is fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:

- 1. The rates proposed by North Hopkins are accepted.
- 2. The purchased water adjustment of \$0.37 per 1,000 gallons as calculated in Appendix A and the rates in Appendix B, attached hereto and incorporated herein, are fair, just, and reasonable and are approved for services rendered on and after March 10, 2009.
- 3. Within 20 days of the date of this Order, North Hopkins shall file with the Commission revised tariff sheets showing the rates approved herein.
