

MOTION FOR LEAVE TO WITHDRAW REQUEST

Applicant **KENERGY CORP.** (“Kenergy”) moves for leave to withdraw the request set forth in its February 18, 2009, letter to the Commission, and in support thereof states as follows:

1. Kenergy’s February 18, 2009, letter requested the Commission to approve a one-time 50% reduction of the customer charge for nondirect serve customers beginning with the March 24, 2009, billing cycle. Kenergy sought approval of this request in order to recognize, albeit in a small way, the hardships its customers had encountered because of the ice storms that occurred in late January 2009.


2. Beginning with the March 24, 2009, billing cycle Kenergy customers were being billed for service provided during the ice storms. Showing the reduction on the bill basically would have been a direct partial setoff to the charges for service during the time in question.

3. On April 8, 2009, when an order in this case still had not been issued, Kenergy management decided that the gesture had lost its meaning and relevance, and that the request should be withdrawn. The undersigned attorney notified Staff Counsel by telephone and followed that up with a fax message, a copy of which is attached hereto and incorporated herein by reference.

4. Kenergy appreciates the time and effort that the Staff and Commission have devoted to this matter and apologizes for any inconvenience.

WHEREFORE, Kenergy moves the Commission for leave to withdraw its request in this case, for issuance of an order closing the case, and Kenergy further moves that it be afforded all proper relief.

As requested this is a follow-up to our telephone conversations earlier today. Kenergy is requesting that its letter petition for one time rate reduction because of outages resulting from the January 2009 ice storms be withdrawn. Kenergy wanted to get the rate reduction in effect beginning with the March 24 billing cycles because those billings covered the consumption period during the ice storms. Now, however, Kenergy feels that because of the delay in possibly being able to implement this, the gesture has lost its meaning and relevance. Kenergy apologizes to the staff and Commission for the time and effort they have devoted to this matter and trust they understand the reasons for this withdrawal.
