ORDER

On December 2, 1999, in Case No. 1999-00312, the Commission approved rates for Millennium Energy, Inc. ("Millennium") and provided for their further adjustment in accordance with Millennium's Gas Cost Adjustment ("GCA") clause.¹

On February 26, 2009, Millennium filed its proposed GCA to be effective April 1, 2009.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

- 1. Millennium's notice includes revised rates designed to pass on to its customers its expected change in gas costs.
- 2. Millennium's notice sets out an Expected Gas Cost ("EGC") of \$3.8825 per Mcf, which is a decrease of \$2.1202 per Mcf from its previous EGC of \$6.0027. In future filings, Millennium should include its supplier notice or tariff sheet in support of its EGC.

- 3. Millennium's notice sets out no Refund Adjustment.
- 4. Millennium's notice sets out a current quarter Actual Adjustment ("AA") of \$.4447 per Mcf. Millennium's total AA is \$1.0733 per Mcf, which is an increase of \$.0831 per Mcf from the previous total AA of \$.9902.
- 5. Millennium's notice sets out a current quarter Balance Adjustment ("BA") of (\$.0176) per Mcf. Millennium's total BA is \$.0315 per Mcf, which is a decrease of \$.0189 per Mcf from the previous total BA of \$.0504.
- 6. Millennium's Gas Cost Recovery Rate is \$4.9873 per Mcf, which is a decrease of \$2.056 per Mcf from the previous rate of \$7.0433.
- 7. The rates in the Appendix to this Order are fair, just, and reasonable, and should be approved for service rendered by Millennium on and after April 1, 2009.

IT IS THEREFORE ORDERED that:

- 1. The rates in the Appendix to this Order are approved for service rendered on and after April 1, 2009.
- 2. Within 20 days of the date of this Order, Millennium shall file with this Commission its revised tariffs setting out the rates authorized herein.
- 3. In future filings, Millennium shall include its supplier notice or tariff sheet in support of its EGC.
