# TRACFONE WIRELESS, INC.'S MOTION TO FILE FIRST AMENDMENT TO PETITION FOR DESIGNATION AS AN ELIGIBLE TELECOMMUNICATIONS CARRIER

Comes now TracFone Wireless, Inc. ("TracFone"), by its undersigned counsel, and hereby moves the Kentucky Public Service Commission ("Commission") for permission to amend its Petition for Designation as an Eligible Telecommunications Carrier ("ETC") in the Commonwealth of Kentucky to clarify its Lifeline service area. By this amendment, TracFone clarifies that it will offer Lifeline service in all areas in Kentucky that are served by AT&T Mobility and T-Mobile. In the second quarter of 2010, TracFone will expand its Lifeline service area to include the areas in Kentucky served by Verizon Wireless. TracFone requests ETC designation statewide in all exchanges to the extent that its underlying carriers, including Verizon Wireless, have facilities and coverage.
