BLUEGRASS WIRELESS' NOTICE OF WITHDRAWAL OF APPLICATION FOR CERTIFICATE OF PUBLIC CONVENIENCE AND NECESSITY

Bluegrass Wireless LLC ("Bluegrass Wireless"), by counsel, hereby respectfully files this notice of withdrawal of its application for a certificate of public convenience and necessity in the above-styled matter with the Public Service Commission of the Commonwealth of Kentucky (the "Commission"). In support of its notice, Bluegrass Wireless states as follows.

- 1. There is a substantial federal tax lien against the real property upon which the proposed Dabney cell site will be located.
- 2. Bluegrass Wireless anticipated that the federal tax lien would be satisfied and released by the time the application became ripe for approval. This has not happened.
- 3. For this reason, Bluegrass Wireless believes the risks associated with constructing the proposed cell site on this encumbered property are too great.
- 4. Because Bluegrass Wireless is withdrawing its application, the community meeting currently scheduled for Tuesday, June 30, 2009 to discuss the application is no longer necessary.
- 5. No public notice has been sent nor legal notice published regarding the community meeting pursuant to the notice requirements in the Commission's order dated May 29, 2009; therefore no confusion should be caused by cancelling the community meeting

6. Bluegrass Wireless hereby advises the Commission that it will probably file a new application involving a different piece of real property within approximately 120 days from the date of this notice.

Wherefore, Bluegrass Wireless LLC requests that the Commission issue an order withdrawing Bluegrass Wireless's application for a certificate of public convenience and necessity to construct the Dabney cell site, and cancelling the community meeting scheduled for June 30, 2009.
