O R D E R

On April 29, 2004, in Case No. 2003-00411,<sup>1</sup> the Commission approved rates for Equitable Gas Company ("Equitable"), a division of Equitable Resources, Inc., and provided for their further adjustment on a quarterly basis in accordance with Equitable's Gas Cost Adjustment ("GCA") clause.

On March 23, 2009, Equitable filed its proposed GCA to be effective May 1, 2009.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Equitable's notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.
2. Equitable's Expected Gas Cost ("EGC") is \$7.4363 per Mcf, which is a decrease of \$2.5992 per Mcf from its previous EGC of \$10.0355 per Mcf.
3. Equitable's notice sets out a current quarter Actual Adjustment ("AA") of (\$1.0497) per Mcf. Equitable's total AA is \$.7638 per Mcf, which is a decrease of (\$.7999) per Mcf from the previous total AA of \$1.5637 per Mcf.

4. Equitable's notice sets out a current quarter Balancing Adjustment ("BA") of \$.0023 per Mcf. Equitable's total BA is (\$.0256) per Mcf, which is an increase of \$.0112 per Mcf from the previous total BA of (\$.0368) per Mcf.

5. Equitable's Gas Cost Recovery Rate is \$8.1745 per Mcf, which is a decrease of \$3.3879 per Mcf from its previous rate of \$11.5624 per Mcf.

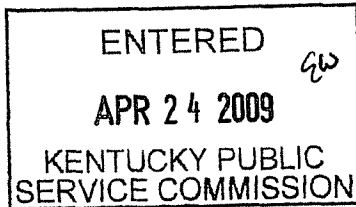
6. The rates in the Appendix to this Order are fair, just, and reasonable, and should be approved for final meter readings by Equitable on and after May 1, 2009.

IT IS THEREFORE ORDERED that:


1. The rates in the Appendix to this Order, attached hereto and incorporated herein, are approved for final meter readings on and after May 1, 2009.
