#### ORDER

On March 31, 2009, Cannonsburg Water District ("Cannonsburg") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.<sup>1</sup>

The Commission, having reviewed the record and being sufficiently advised, finds that:

- Cannonsburg purchases water from the City of Ashland ("Ashland") and
   Big Sandy Water District ("Big Sandy").
- 2. Ashland notified Cannonsburg that, effective March 1, 2009, its wholesale rate to Cannonsburg would increase from \$1.43 per 1,000 gallons to \$1.89 per 1,000 gallons. On October 30, 2008<sup>2</sup> and on December 18, 2008,<sup>3</sup> the Commission authorized Big Sandy to adjust its wholesale rate to Cannonsburg to \$2.05 per 1,000 gallons, effective January 1, 2009.

- 3. Cannonsburg proposed a purchased water adjustment factor of \$0.58 per 1,000 gallons.
  - 4. Cannonsburg proposed an effective date of April 13, 2009.
- 5. In it's application, Cannonsburg misstated the base rate and changed rate from Big Sandy. Big Sandy's changed wholesale rate to Cannonsburg is \$2.05 per 1,000 gallons, which became effective January 1, 2009. The base rate used to calculate Cannonsburg's purchased water adjustment is \$1.95 per 1,000 gallons.
- 6. During the 12 months ended November 31, 2008, Cannonsburg purchased 423,724,000 gallons of water from Ashland, 2,626,900 gallons from Big Sandy, and sold 336,061,200 gallons. The increase in the cost of purchased water is \$195,175.73, resulting in a purchased water adjustment factor of \$0.58 per 1,000 gallons.
- 7. The purchased water adjustment factor of \$0.58 per 1,000 gallons is fair, just, and reasonable and should be approved.
- 8. Cannonsburg's proposed tariff sheet, which was included in Cannonsburg's application, contained incorrect rates.

#### IT IS THEREFORE ORDERED that:

- 1. The rates proposed by Cannonsburg are denied.
- 2. The purchased water adjustment factor of \$0.58 per 1,000 gallons as calculated in Appendix A is approved.
- 3. The rates in Appendix B, attached hereto and incorporated herein, are fair, just, and reasonable and are approved for service rendered on or after April 13, 2009.

4. Within 20 days of the date of this Order, Cannonsburg shall file with the Commission revised tariff sheets showing the rates approved herein.
