## ORDER

On July 31, 2007, in Case No. 2006-00464,<sup>1</sup> the Commission approved rates for Atmos Energy Corporation ("Atmos") and provided for their further adjustment in accordance with Atmos's Gas Cost Adjustment ("GCA") clause.

On March 31, 2009, Atmos filed its GCA to be effective May 1, 2009. Atmos filed amended GCA schedules on April 7, 2009 and an amended tariff sheet on April 8, 2009.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

- 1. Atmos's notice includes revised rates designed to pass on to its sales customers its expected change in wholesale gas costs.
- 2. Atmos's Expected Gas Cost ("EGC") for firm sales customers is \$5.8514 per Mcf, a decrease of \$.4328 per Mcf from the previous EGC of \$6.2842 per Mcf. Atmos's EGC for interruptible sales customers is \$4.9388 per Mcf, a decrease of \$.3045 per Mcf from the previous EGC of \$5.2433 per Mcf.
- 3. Atmos's notice sets out no current period Refund Factor ("RF"). The total RF is \$0 per Mcf for firm sales customers and \$0 per Mcf for interruptible sales

customers, and represents no change from the prior RF. Atmos's notice sets out no RF for T-2 firm transportation customers, T-2 interruptible service, T-3 carriage service, or T-4 firm carriage service.

- 4. Atmos's notice sets out a Correction Factor ("CF") of \$.0446 per Mcf, which is a decrease of \$.8885 per Mcf from the previous CF of \$.9331 per Mcf.
- 5. Atmos's notice sets out its Performance Based Rate Recovery Factor ("PBRRF") of \$.0906 per Mcf, which is effective from February 1, 2009 until February 1, 2010. This PBRRF factor represents no change from the previous PBRRF factor.
- 6. Atmos's GCAs are \$5.9866 per Mcf for firm sales customers and \$5.0740 per Mcf for interruptible sales customers. The impact on firm sales customers is a decrease of \$1.3213 per Mcf from the previous GCA of \$7.3079 per Mcf. The impact on interruptible sales customers is a decrease of \$1.1930 per Mcf from the previous GCA of \$6.2670 per Mcf.
- 7. The rates in the Appendix attached hereto and incorporated herein are fair, just and reasonable, and should be approved for final meter readings by Atmos on and after May 1, 2009.

#### IT IS THEREFORE ORDERED that:

- 1. The rates in the Appendix to this Order are approved for final meter readings on and after May 1, 2009.
- 2. Within 20 days of the date of this Order, Atmos shall file with the Commission its revised tariffs setting out the rates authorized herein.
