COMMISSION STAFF'S DATA REQUEST  
TO DWAIN AND DEBRA STIGALL

Dwain and Debra Stigall ("Stigalls"), pursuant to 807 KAR 5:001, are to file with the Commission the original and two copies of the following information, with a copy to all parties of record. The information requested herein is due on or before June 24, 2009. Responses to requests for information shall be appropriately bound, tabbed and indexed. Each response shall include the name of the witness responsible for responding to the questions related to the information provided.

Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.


The Stigalls shall make timely amendment to any prior response if they obtain information which indicates that the response was incorrect when made or, though correct when made, is now incorrect in any material respect. For any request to which

the Stigalls fail or refuse to furnish all or part of the requested information, the Stigalls shall provide a written explanation of the specific grounds for their failure to completely and precisely respond.

Careful attention should be given to copied material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request. When applicable, the requested information shall be separately provided for total company operations and jurisdictional operations.

1. The Application for Transfer of Ownership states that one of the sellers, Barbara McGowan, has agreed to stay on as the licensed operator until the purchasers are able to obtain their own licenses. However, as stated in the attached letters from the Division of Water, Barbara McGowan's license expired in 2006 and was terminated. Explain in writing how Lovelaceville Water Company ("Lovelaceville") will obtain the services of a licensed operator to oversee the utility's day-to-day operations until such time as the purchasers are able to obtain their own licenses.

2. Provide Lovelaceville's Annual Report for calendar year 2008.
