COLUMBIA GAS OF KENTUCKY, INC.'S STATEMENT THAT THE RECORD IS COMPLETE

On April 23, 2009, Columbia Gas of Kentucky, Inc. ("Columbia") filed its application with the Public Service Commission of Kentucky ("Commission") to issue, pursuant to KRS §§ 278.030, 278.040, and 278.220, an order authorizing Columbia to establish regulatory assets and/or liabilities for pension costs and other post-retirement benefits costs ("OPEB"). The Commission's procedural schedule established in this proceeding provided for the filing of intervenor testimony or intervenor comments by July 13, 2009. No such testimony or comments were filed. Accordingly, on July 24, 2009, the Commission issued an Order directing each party to submit, by August 3, 2009, a written request for a hearing or a statement that they believe the record is complete and that the matter shall stand submitted for decision

In compliance with the Commission's Order of July 24, 2009, Columbia submits that given the lack of testimony filed by any parties other than Columbia, the record is complete and this matter should stand submitted for decision.
