Several concerned residents have already mentioned to you several areas of concern about the proposed rate increase, and I would like to mention one additional concern. **Big Bear Resort is listed for sale.**

The resort is listed with LoopNet, a national internet real estate company. The listing was verified as active on 10/05/09 and the ID number is 16230704. Included in the description of the property is the wastewater treatment plant as well as the 2 condominium communities. This information has **NOT** been mentioned to the condominium unit owners.

Since the wastewater treatment plant serves Big Bear Resort as well as the Dens and the Treetops Condominium Communities, I question the motives of Meier / Caldemeyer as well as the validity of the proposed rate increase. I respectfully request the Public Service Commission to analyze and review this information in connection with the proposed rate increase.
