ORDER

On May 8, 2009, Jessamine County Water District No. 1 ("Jessamine District") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹

The Commission, having reviewed the record and being sufficiently advised, finds that:

- Jessamine District purchases water from the City of Nicholasville ("Nicholasville").
- 2. Nicholasville notified Jessamine District, effective with its June 1, 2009 billing, Nicholasville's wholesale water rate to Jessamine District would increase from \$2.14 per 1,000 gallons to \$2.43 per 1,000 gallons. Jessamine District proposes to increase the water rates to its customers effective June 15, 2009.
- 3. During the 12 months ending March 31, 2009, Jessamine District purchased a total of 205,897,600 gallons of water and sold 165,146,790 gallons. The

increase in the cost of purchased water is \$59,710, resulting in a purchased water adjustment of \$0.36 per 1,000 gallons.

- 4. The rates proposed by Jessamine District should be approved.
- 5. The purchased water adjustment of \$0.36 per 1,000 gallons is fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:

- 1. The proposed rates by Jessamine District are approved.
- 2. The purchased water adjustment of \$0.36 per 1,000 gallons as calculated in Appendix A is approved.
- 3. The rates in Appendix B, attached hereto and incorporated herein, are fair, just, and reasonable and are approved for services on or after June 15, 2009.
 - 4. The tariff sheets filed by Jessamine District are approved as filed.
