#### **CERTIFICATE OF COMPLETED NOTICE**

Pursuant to the Rules Governing Tariffs (effective August 4, 1984), I hereby certify that I am Lonnie E. Bellar, Vice President, State Regulation and Rates for Kentucky Utilities Company ("KU" or "Company"), a utility furnishing retail electric service within the Commonwealth of Kentucky which, on the 26th day of June, 2009, filed an application with the Kentucky Public Service Commission seeking an order granting KU Certificates of Public Convenience and Necessity for the construction of Selective Catalytic Reduction Nitrogen Oxides emission control technology at E.W. Brown Unit 3 and for the construction of new landfills at the Ghent and Trimble County Generating Stations, and pursuant to KRS 278.183 approving an amended compliance plan for purposes of recovering the costs of new pollution control facilities through its Environmental Surcharge tariff. Notice to the public of a hearing in this matter has been completed in substantial or complete compliance with Section 8(5) of 807 KAR 5:011 as follows:
