O R D E R


On September 14, 2009 Louisville Gas and Electric Company (“LG&E”) filed a motion requesting the Commission to: 1) schedule an informal conference for the purposes of discussing the issues in this case and exploring the potential for a settlement; and 2) revise the procedural schedule to provide LG&E an opportunity to file rebuttal testimony. According to LG&E, the only intervenor in the proceeding, Kentucky Industrial Utility Customers, has no objection to the proposed modification to the procedural schedule.

The Commission, having considered the motion and finding good cause, HEREBY ORDERS that:


1. An informal conference is scheduled at 9:00 a.m., Eastern Daylight Time, October 1, 2009, in Conference Room 2 of the Commission's offices at 211 Sower Boulevard, Frankfort, Kentucky for the purposes of discussing the issues related to the case and exploring the potential for a settlement.
2. LG&E shall be entitled to file rebuttal testimony in accordance with the procedural schedule in the Appendix.

3. The procedural schedule attached as the Appendix shall be followed in this case. This schedule shall supersede the procedural schedule appended to the Commission's August 6, 2009 Order.
