ORDER

On October 11, 1993, in Case No. 1993-00111, the Commission approved rates for Belfry Gas Company, Inc. ("Belfry") and provided for their further adjustment in accordance with Belfry's Gas Cost Adjustment ("GCA") clause.¹

On June 1, 2009, Belfry filed its GCA to be effective July 1, 2009.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

- 1. Belfry's notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.
- 2. Belfry's notice sets out an Expected Gas Cost ("EGC") of \$4.8530 per Mcf, a decrease of \$.8715 per Mcf from its prior EGC of \$5.7245 per Mcf.
- 3. Belfry's notice sets out no Refund Adjustment ("RA") for the current quarter. Belfry's total RA is \$.0000 per Mcf, an increase of \$.0008 per Mcf from the prior total RA of (\$.0008) per Mcf.

- 4. Belfry's notice sets out a current quarter Actual Adjustment ("AA") of (\$.3910) per Mcf. Belfry's total AA calculation did not include the AAs from the three previous quarters. Correcting this produces a total AA of (\$2.1235) per Mcf, which is a decrease of \$.3361 per Mcf from its previous total AA of (\$1.7874) per Mcf.
 - 5. Belfry's notice sets out no Balance Adjustment.
- 6. Belfry's GCA is \$2.7295 per Mcf, which is a decrease of \$1.2068 per Mcf from its previous rate of \$3.9363 per Mcf.
- 7. The rates in the Appendix to this Order are fair, just, and reasonable, and should be approved for billing for service rendered by Belfry on and after July 1, 2009.

IT IS THEREFORE ORDERED that:

- 1. Belfry's proposed rates are denied.
- 2. The rates in the Appendix attached hereto and incorporated herein are approved for billing for service rendered on and after July 1, 2009.
- 3. Within 20 days of the date of this Order, Belfry shall file with the Commission its revised tariff sheets setting out the rates authorized herein.
