ORDER

Mountain Water District, a water district organized pursuant to KRS Chapter 74, owns and operates water distribution and sewage disposal facilities that serve approximately 16,450 customers in Pike County, Kentucky. It is a utility subject to Commission jurisdiction. KRS 278.015. Mountain Water District is administered by a five-member board of commissioners that controls and manages the affairs of the district.

KRS 74.455(1) provides:

From and after the creation and establishment of a water district and the appointment of water commissioners to manage the affairs of the district, and following the acquisition or construction by any duly created and established water district of a public water system, and the consequent establishment of regulatory jurisdiction over such water district by the Public Service Commission of Kentucky, the Public Service Commission may remove any water commissioner from his office for good cause, including, inter alia, incompetency, neglect of duty, gross immorality, or nonfeasance, misfeasance, or malfeasance in office, including without limiting the generality of the foregoing, failure to comply with rules, regulations, and orders issued by the Public Service Commission.

KRS 74.020(1)(a) requires that members of a water district's board of commissioners "be residents of the district, or of any incorporated or unincorporated

area served by the district in the county in which the district was originally established." Any commissioner who moves "his residence outside of the jurisdictional limits . . . has disqualified himself and . . . [is] subject to removal." OAG 76-381.

Toni Akers and Michael Litafik ("Respondents") are members of Mountain Water District's Board of Commissioners. Respondents have informed the Commission that they no longer reside within Mountain Water District's territory or any area that it serves. See Exhibits A and B to this Order.

In light of Respondents' admission, the Commission finds *prima facie* evidence exists that Respondents no longer reside within Mountain Water District's territory and are presently disqualified from continued service as members of Mountain Water District's Board of Commissioners and that, as a result of this disqualification, good cause exists for their removal from that Board.

IT IS THEREFORE ORDERED that:

- 1. Pursuant to KRS 74.455, this proceeding is initiated to determine whether Respondents presently reside within Mountain Water District's territory and whether, if they no longer reside within the water district's territory, they are disqualified from continued service as members of Mountain Water District's Board of Commissioners and must be removed from that Board.
- 2. Within 10 days of service of this Order, each Respondent shall file with the Commission a written response to this Order and shall specifically admit or deny the allegation that he resides outside Mountain Water District's territory. In this response, each shall further state whether he waives his right to a public hearing as provided in KRS 74.455(2).

3. Unless he waives his right to a public hearing in this matter, each Respondent shall appear at the Commission's offices at 211 Sower Boulevard on July 2, 2009 at 11:00 a.m., Eastern Daylight Time, for a public hearing on whether he presently resides within Mountain Water District's territory and whether, if he no longer resides within the water district's territory, he is disqualified from continued service as a member of Mountain Water District's Board of Commissioners and must be removed from that Board.

4. Pursuant to KRS 278.080, Richard Raff is designated as hearing examiner to conduct the scheduled hearing in this matter and to perform all actions necessary to ensure the orderly conduct of this hearing, to include administering oaths, receiving evidence, and ruling on motions and objections presented at this hearing.

5. A copy of this Order shall be served upon the County Judge/Executive of Pike County.
