Louisville Gas and Electric Company Show Cause Proceeding

Pursuant to the Commission's July 20, 2009 Order, an informal conference was held at the Commission's offices on August 12, 2009. A copy of the sign in sheet is attached hereto.

The purpose of the conference was to discuss the facts and circumstances surrounding the February 1, 2009 incident involving a Louisville Gas and Electric Company ("LG&E") contractor, C.W. Wright Construction Company, near Natchez Lane in Louisville, Jefferson County, Kentucky. As a result of the discussion, an agreement in principle was reached which, if accepted by the Commission, would eliminate the need for a hearing in this case. The settlement agreement provides for the payment by LG&E of a civil penalty in the amount of \$6,000. Staff agreed to work with LG&E to finalize a Stipulation reflecting the agreement in principle.
