ORDER

On June 15, 2009, Elkhorn Water District ("Elkhorn") submitted an application for approval to reduce its rates pursuant to the purchased water adjustment procedure. Elkhorn submitted the application due to a decrease in the wholesale rate for water purchased from the Frankfort Electric and Water Plant Board ("Plant Board"). The application failed to meet the Commission's minimum filing requirements set out in 807 KAR 5:068. Elkhorn was notified of the deficiencies by letter dated June 22, 2009. On July 8, 2009, Elkhorn submitted information curing the deficiencies.

The Plant Board implemented an increase in the wholesale rate to Elkhorn prior to approval of that increase by the Commission. Elkhorn passed that increase on to its customers through the purchased water adjustment process in Case No. 2009-00003.² The Plant Board was ultimately required to reduce its wholesale rate and refund certain funds already paid by Elkhorn.³ Pursuant to 807 KAR 5:068, Section 2(4), Elkhorn has

now applied to the Commission for authority to pass that reduced rate along to its customers, but it has not addressed the issue of the required refunds. The Commission's Order in the Plant Board case also required that "[u]pon receipt of the Plant Board's refund, each of the Intervenors [one of which is Elkhorn] shall immediately apply to the Commission for authority to make adjustments on the amounts charged to its customers' bills, pursuant to 807 KAR 5:068, Section 2(4)." The Plant Board has notified Commission Staff that it has refunded each wholesale purchaser the amount owed, via a credit on the June billing statement.

KRS 278.015 permits a water district "to increase its rates commensurate with the wholesale supplier." After a water district files the appropriate documents with the Commission, we must "approve the filing or establish revised rates by order no later than thirty (30) days" after the documents are filed, pursuant to that statute. This Order shall serve to establish revised rates based on the reduced wholesale rate approved for the Plant Board. However, additional information is necessary in order to calculate the refund owed to Elkhorn's customers. An Order authorizing Elkhorn's refund to its customers based on 807 KAR 5:068, Section 2(4), shall be issued at a later date.

The Commission, having reviewed the record and being sufficiently advised, finds that:

- 1. Elkhorn purchases water from the Plant Board.
- 2. The Plant Board reduced its wholesale rate to Elkhorn per Commission Order in Case No. 2009-00250, effective April 6, 2009, from \$1.822 per 1,000 gallons to \$1.704 per 1,000 gallons.

- 3. Elkhorn proposed a purchased water adjustment factor of \$0.18 per 1,000 gallons. Elkhorn failed to follow the method for calculating a purchased water adjustment factor as set out in 807 KAR 5:068.
- 4. The base rate, as defined by 807 KAR 5:068, Section 1, to be used in this case shall be \$1.822 per 1,000 gallons. The changed rate to be used in this case shall be \$1.704 per 1,000 gallons.
- 5. During the 12 months ending April 30, 2009, Elkhorn purchased 66,613,300 gallons of water from the Plant Board, and it sold 61,161,100 gallons. The decrease in the cost of purchased water is \$7,860.37, resulting in a purchased water adjustment factor of \$-0.13 per 1,000 gallons.
- 6. The purchased water adjustment factor of \$-0.13 per 1,000 gallons is fair, just, and reasonable and should be approved.
- 7. The Plant Board refunded the amount owed Elkhorn, via a credit on the June billing statement for charges, as a result of the Plant Board placing its proposed rates into effect prior to resolution of Case No. 2008-00250 pursuant to KRS 278.190; but additional information is needed to calculate the refund factor to be used by Elkhorn.
- 8. Elkhorn has not yet received Commission authority to make refunds to its customers' bills under 807 KAR 5:068, Section 2(4).

IT IS HEREBY ORDERED that:

- 1. The rates proposed by Elkhorn are denied.
- 2. The purchased water adjustment factor of \$-0.13 per 1,000 gallons, as calculated in Appendix A, is approved.

- 3. The rates in Appendix B, attached hereto and incorporated herein, are fair, just, and reasonable, and are approved for services on or after June 18, 2009.
- 4. Within 20 days of the date of this Order, Elkhorn shall file with the Commission revised tariff sheets showing the rates approved herein.
- 5. Elkhorn shall not make any further adjustments or refunds to its customers' bills until it has received authority by future Order of this Commission.
- 6. Elkhorn shall, within 10 days of the date of this Order, file with the Commission the original and six copies of the information listed in Appendix C, with a copy to all parties of record.
- a. Responses to requests shall be appropriately bound, tabbed and indexed and shall include the name of the witness responsible for responding to the questions related to the information provided.
- b. Each response shall be accompanied by a signed certification of the preparer or person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.
- c. Elkhorn shall make timely amendment to any prior response if it obtains information which indicates that the response was incorrect when made or, though correct when made, is now incorrect in any material respect.
- d. For any request to which Elkhorn fails or refuses to furnish all or part of the requested information, that party shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.
