ORDER

On June 19, 2009, North McLean County Water District ("North McLean") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹

The Commission, having reviewed the record and being sufficiently advised, finds that:

- 1. North McLean purchases water from the city of Calhoun ("Calhoun"), city of Livermore ("Livermore"), and the West Daviess County Water District ("West Daviess").
- 2. West Daviess raised its wholesale rate to North McLean effective June 1, 2009, from \$2.26 per 1,000 gallons to \$2.36 per 1,000 gallons.
- 3. North McLean proposed a purchased water adjustment factor of \$0.01 per 1,000 gallons.
 - 4. North McLean proposed an effective date of July 10, 2009.
- 5. During the 12 months ended April 30, 2009, North McLean purchased 112,600,600 gallons of water from Calhoun, 1,269,500 gallons from Livermore, and 12,603,700 gallons from West Daviess, and it sold 102,009,800 gallons. The increase

in the cost of purchased water is \$1,260.37, resulting in a purchased water adjustment factor of \$0.01 per 1,000 gallons.

6. The purchased water adjustment factor of \$0.01 per 1,000 gallons is fair, just, and reasonable and should be approved.

IT IS HEREBY ORDERED that:

- 1. The rates proposed by North McLean are approved.
- 2. The purchased water adjustment factor of \$0.01 per 1,000 gallons, as calculated in Appendix A, is approved.
- 3. The rates in Appendix B, attached hereto and incorporated herein, are fair, just, and reasonable and are approved for services rendered on or after July 10, 2009.
- 4. Within 20 days of the date of this Order, North McLean shall file with the Commission revised tariff sheets showing the rates approved herein.
