#### ORDER

On June 24, 2009, Jessamine-South Elkhorn Water District ("Jessamine-South Elkhorn") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.<sup>1</sup>

The Commission, having reviewed the record and being sufficiently advised, finds that:

- 1. Jessamine-South Elkhorn purchases water from Kentucky-American Water Company ("KAWC") and the city of Nicholasville ("Nicholasville").
- 2. KAWC and Nicholasville notified Jessamine-South Elkhorn that they would increase their wholesale water rates effective June 1, 2009. KAWC's wholesale water rate to Jessamine-South Elkhorn would increase from \$2.68381 per 1,000 gallons to \$3.27067 per 1,000 gallons and Nicholasville's wholesale water rate to Jessamine-South Elkhorn would increase from \$2.14 per 1,000 gallons to \$2.43 per

1,000 gallons.<sup>2</sup> Jessamine-South Elkhorn proposes to increase the water rates to its customers effective July 5, 2009.

- 3. During the 12 months ending May 31, 2009, Jessamine-South Elkhorn purchased a total of 282,639,000 gallons of water from KAWC and a total of 28,377,800 gallons of water from Nicholasville and sold a total of 257,230,180 gallons of water. The increase in the cost of purchased water is \$174,099.09 resulting in a purchased water adjustment of \$0.68 per 1,000 gallons.
- 4. A purchased water adjustment of \$0.68 per 1,000 gallons is fair, just, and reasonable.

#### IT IS HEREBY ORDERED that:

- 1. Jessamine-South Elkhorn's proposed rates are approved.
- 2. The purchased water adjustment increase of \$0.68 per 1,000 gallons as calculated in Appendix A is approved and the rates in Appendix B, attached hereto and incorporated herein, are fair, just, and reasonable and are approved for services rendered on and after July 5, 2009.
- 3. The tariff sheets filed by Jessamine-South Elkhorn in the application are approved.
