## ORDER

On July 21, 2009, the Commission issued an Order in this matter which, *inter alia*, established new rates for service that Ohio County Water District ("Ohio District") provides. We acted pursuant to KRS 278.023, which requires us to accept agreements between water utilities and the U.S. Department of Agriculture and to issue the necessary orders to implement the terms of such agreements within 30 days of satisfactory completion of the minimum filing requirements. The rates set forth in our Order of July 21, 2009 were set forth in an agreement between Ohio District and Rural Development ("RD"), an agency of the U.S. Department of Agriculture.

On August 11, 2009, Ohio District moved for modifications of the Order of July 21, 2009 to reflect modifications in its agreement with RD. More specifically, RD had modified its agreement with Ohio District to require that the wholesale service rates set forth in the agreement apply to all wholesale customers, not merely the cities of Beaver Dam and Fordsville.

As KRS 278.023 provides no discretion on the Commission's part to independently review and weigh these modifications, we find that Ohio District's motion

must be granted and the wholesale rates set forth in our Order of July 21, 2009 be applied to all wholesale customers.

## IT IS THEREFORE ORDERED that:

- 1. Ohio District's Motion to Amend Order is granted.
- 2. Ohio District shall charge the rates set forth in the Appendix for service rendered on and after the date of this Order.
- 3. All provisions of the Commission's Order of July 21, 2009 that are not in conflict with this Order shall remain in full force and effect.
