O R D E R

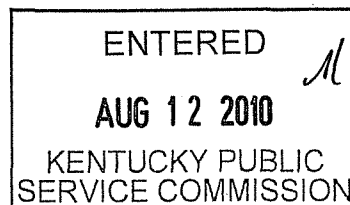
By Order dated June 22, 2010 ("June 22 Order"), the Commission granted the Joint Motion of the parties, Windstream Kentucky East, LLC ("Windstream") and New Cingular Wireless PCS, LLC d/b/a AT&T Mobility ("AT&T"), to suspend the most recent procedural schedule. The parties requested additional time to participate in discovery and to complete other pre-hearing procedural matters. In the June 22 Order, the Commission also continued the formal hearing which had been scheduled to occur on July 27 and 28, 2010. The parties were ordered to submit a new proposed amended joint procedural schedule no later than July 30, 2010.

The parties submitted a new proposed schedule on July 30 as required. Having reviewed the submission, the Commission finds that the Joint Proposed Amended Procedural Schedule should be adopted by the Commission and followed by all parties to this proceeding. The *Joint Proposed Amended Procedural Schedule* is provided in the Appendix to this Order. The Commission also finds that the dates for the formal hearing will be outlined by the Commission in a separate Order to be issued within the coming weeks.


IT IS HEREBY ORDERED that:


