Come now the parties and for their Joint Status Report state the following:

South Shore Waterworks and the City of Greenup have engaged in meaningful and deep discuss and negotiations since the entry of the last Order of the Public Service Commission ("PSC"). Although no final agreement has been reached, the parties have made significant progress in resolving their disputes in an attempt to come to an agreement that accomodates the needs and desires of both parties.

At this time, the parties believe it would be extraordinarily helpful to conduct an informal conference on this matter with a representative of the PSC. The parties are at the point where issues have arisen that require the agency's input and it is believed by both sides that a conference would help greatly in bringing this matter to its final conclusion.


As such, the parties respectfully request that the PSC do the following:
