Pursuant to the Commission's August 18, 2009 Order, on October 7, 2009, representatives of Kentucky Power Company ("Kentucky Power") and Commission Staff ("Staff") met at the Commission's offices to discuss Kentucky Power's testimony and responses to the first round of data requests in the current examination of the company's environmental surcharge mechanism. Staff asked a few clarifying questions related to information included in the first data request. The topics discussed were related to operations and maintenance expenses and clarification of the debt schedules in Item No. 4 of the response to the first data request.
