RE: Informal Conference of October 28, 2009

Pursuant to the Commission's October 26, 2009 Notice of Informal Conference, on October 28, 2009, representatives of Kentucky Power Company ("Kentucky Power") and Commission Staff ("Staff") met at the Commission's offices to discuss Kentucky Power's response to Staff's questions from the Informal Conference held October 7, 2009 in the current examination of the company's environmental surcharge mechanism. A list of attendees is attached to this memorandum as Appendix A.

Staff asked a few clarifying questions related to information included in the response. The topics discussed were related to clarification of the Short-Term financing and Accounts Receivable Financing debt schedules. Staff also requested electronic copies of the aforementioned debt schedules. There being no other questions, the meeting was adjourned.
