ORDER TO SATISFY OR ANSWER



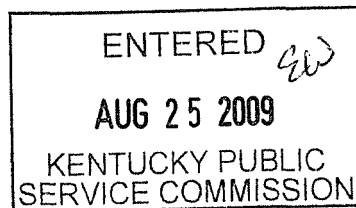
Should documents of any kind be filed with the Commission in the course of this proceeding, the documents shall also be served on all parties of record.

Per my June 2, 2009, complaint. I received a voice mail message from an employee stating that Duke Energy had replaced a broken connection and fixed the meter and that this would resolve my complaint. The message also stated that as to why I was charged for much more usage the last several years, during the same months, compared to usage as reflected by the new meter, it must be due to conservative use of electric. This is not a satisfactory explanation because my electric use has not changed.

I called the employee back immediately, but the call has not been returned. I want this issue resolved too.

Dear Sir/Madam:


I have the above-referenced account with Duke Energy. I have owned the property which the electric services for 9 years. Last fall, Duke Energy stated that it could read the meter electronically from the office, and that I would no longer have to call in the readings. Later, it stated that this was not correct and that I had been getting estimated bills. I then went outside to read the meter and it was not registering/working. I then scheduled a day for Duke to come out and replace the meter.

Duke did not appear on the scheduled day to change the meter. I called, complained and waited for about two weeks for a supervisor to call back and schedule another day. Finally, Duke changed the meter. During this time, I continued to mail in \$70 payments because I did not want to receive a large bill. I received bills which reflected that I owed hundreds of dollars. See the enclosed February 2009 and March 2009 bills.

After the change, I received the enclosed bill which shows a credit. See the enclosed "no date" bill. I called Duke twice, I think, and ask why the Electric Usage graph shows that I used so much more electric in 2008 than I am currently using with a new meter. I could not get an answer to my question.

I live alone, except for dogs, and use very little electric. I think I have been overcharged for years, and I can't get an explanation from Duke. Please help. Thanks.

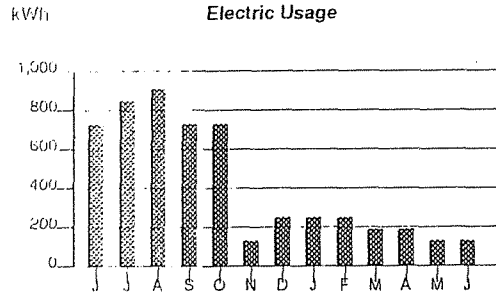

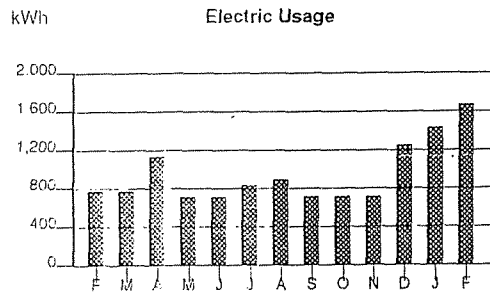

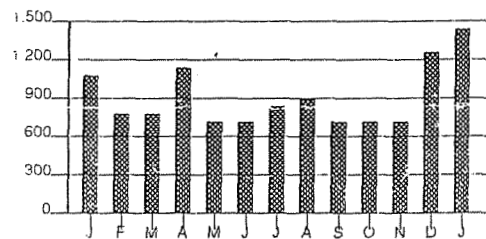
