Response: The existing pipeline had been in place since 1929. The easement for that line cannot be located.

Response: See map attached as exhibit 2 to NEUC's September 8, 2009 Answer.

b. The steel pipe was very old and had cathodic protection problems. Because of the

low operating pressure of the line, it was unnecessary to replace the line with steel,

which has a much greater cost.

a. Yes. The Watson line was moved approximately 75 feet from the existing pipeline.

The replacement pipe on the mall property is approximately 2 to 3 feet from the

existing steel pipeline.

b. August 5, 2009.

c. Mr. Watson, the property owner, requested a relocation due to construction in the

area.

d. Yes. Mr. Watson's property on Bryan St.

e. The pipeline was relocated to an area that placed it out of the future construction

site at the request of the property owner.

f. Approximately 200 feet of pipe.

14. Did NEUC obtain an easement to run the gas main or any of its other facilities on the private property listed in response to Data Request 13 (d)? If yes, what is the date of the easement? Please provide a copy of the easement.

Witness: Freeman

Response: NEUC obtained a verbal agreement with the Patrick Watson in June of 2007.

NEUC had an existing easement for the steel pipeline across the mall property. There are no documents for either agreement.

15. Do you have any agreements, written or oral with the owner of the property referenced in Data Request 13 (d) permitting NEUC to run its main(s) across the property referenced in Data Request 13 (d)? If yes, what was the agreement? Please provide a copy of any document that memorializes the agreement.

Response: Yes, verbal agreement

16. Does NEUC run any main lines, service lines or another other facility through the property at 1200 Bryant Street? If yes, does NEUC have an easement from the property owner of 1200 Bryant Street? If yes, what is the date of the easement? Please provide a copy of said easement.

Response: NEUC cannot identify 1200 Bryant Street. NEUC obtained verbal agreements from all property owners of the property affected by the pipeline replacement.


