ORDER

On August 24, 2009, East Daviess Water Association ("East Daviess") submitted an application for authority to revise certain nonrecurring charges. On August 31, 2009, the Commission notified East Daviess of deficiencies in its application. On September 3, 2009, East Daviess filed information to cure these deficiencies. On November 2, 2009, Commission Staff submitted its first information request to East Daviess. East Daviess responded to the information request on November 16, 2009. Commission Staff submitted its second request for information to East Daviess on November 25, 2009. East Daviess responded to the second information request on December 7, 2009. The record is now complete and the matter stands ready for decision.

The Commission, having reviewed the record and being sufficiently advised, finds that:

- 1. East Daviess has provided adequate evidence of the individual expenses incurred to provide the services associated with the proposed charges.
- 2. The proposed charges are equal to the expenses incurred to provide the associated services.

3. The charges set forth in the Appendix to this Order are fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:

- 1. East Daviess' proposed increase in rates is approved.
- 2. The charges in the Appendix are approved for services rendered on and after the date of this Order.
- 3. Within 20 days of the date of this Order, East Daviess shall file revised tariff sheets with the Commission showing the rates approved herein.
