## JOINT RESPONSE OF MOVANTS ATTORNEY GENERAL OF COMMONWEALTH OF KENTUCKY AND KIUC TO E.ON COMPANIES' REPLY FOR MOTION TO RECONSIDER

Come now the Attorney General of the Commonwealth of Kentucky, by and through his Office of Rate Intervention, and Kentucky Industrial Utility Customers, Inc. [hereinafter jointly referred to as "Joint Respondents"], and state as follows for their Joint Response to the EON Companies' Reply for Motion to Reconsider the Commission's Order dated October 21, 2009 in the above-styled matter.

In simplest terms we agree with the Companies that at this point little remains to be said. The legal positions of the parties have been fully briefed. But we do need to make one thing clear so that there is no later misunderstanding. If a surcharge is granted in this case, then it is very likely that the Attorney General and/or KIUC will appeal and seek refunds of ratepayer collections that we consider to be unlawful. If the Companies elect to continue with the

discretionary wind power contracts under those conditions, then they have voluntarily assumed that risk.
