CONTRACT

WATER MANAGEMENT SERVICE

BETWEEN Gatewood Water Service AND Northeast Woodford Water District

FOR A FEE of \$1.80, per meter, per month, which amount shall be due at the end of each month and payable within ten (10) days GATEWOOD WATER SERVICE agrees to provide for the NORTHEAST WOODFORD WATER DISTRICT (hereafter known as the District) the following services:

1. Each water meter of the District shall be read on a monthly basis.
2. Any questionable meter shall be re-read as needed or requested
3. Two water samples shall be pulled each month and delivered for analysis as required by the Division of Water.
4. Reports (as required) shall be filed with the Division of Water.
5. Water hydrants shall be flushed each spring and fall of each year (and as complaints are filed with the District) to insure the quality of the water of the District

GATEWOOD WATER SERVICE will agree to:

1. Keep certified operators on the payroll to run the District.
2. Maintain cost of replacing meter bottoms on existing meters or on an "as needed" basis.
3. Inspect pumping station and chlorinator on a regular basis making any minor adjustments that would be required for the pump and chlorinator to run at maximum efficiency. Gatewood Water Service will be responsible for keeping chlorine in stock, with the District being responsible for the cost of the chlorine
4. Complete and file Public Service Commission reports as required.
5. Be available as needed to meet with Division of Water or Public Service Commission as a representative of the District.
6. Be available for general complaints and public relations work on behalf of the District.
7. Have personnel on duty 24 hours a day - 365 days a year and have equipment available to handle most any related problem the District may have.
8. Spot check inspection on any work being done by other contractors in the District.  
(If a full time inspection is required, Gatewood Water Service will also offer to provide this service on a per job basis - with prior approval of the District)

ADDITIONAL EXPENSES OR COSTS:

SHORT METERS - \$75.00/each

(Any meter that does not require crossing under a roadway or require less than 30 feet of digging from the main, with the District standing costs of all parts and supplies)

LONG METERS - \$200.00/each

(Any meter that crosses under a roadway shorter than 60 feet will be provided with the District standing costs of all parts and supplies)

LEAK - \$75.00/each

(For each leak taking less than five (5) hours to repair. Over five (5) hours will be done for an additional \$20.00 per hour - over the first five (5) hours.

THIS DISTRICT WILL STAND THE EXPENSE FOR ALL PARTS AND SUPPLIES USED

If footage on any meter runs over the above specified lengths, there will be a per foot charge - which will be set at time District approves meter.

There will be a charge for removing a pump motor and taking same to Lexington KY. for rebuilding of \$75.00, with the District standing the cost of the rebuilding.

GATEWOOD WATER SERVICE WILL also provide the District on an as needed basis and a predetermined charge before the work is done:

1. Certified meter testing
2. Grass cutting around the tank
3. General clean up of the tank (this does not include painting)
4. Construction of pipeline (done on a contract basis)

THIS CONTRACT WILL BE IN EFFECT FOR FOUR (4) YEARS FROM: August, 1985 THROUGH AUGUST, 1989
