NOTICE OF BIG RIVER TELEPHONE COMPANY, LLC'S ADOPTION OF THE WINDSTREAM KY EAST-INSIGHT INTERCONNECTION AGREEMENT

Big River Telephone Company, LLC ("Big River Telephone"), pursuant to Section 252(i) of the Telecommunications Act of 1996 ("Act"), 47 U.S.C. § 252(i), hereby files this Notice of Intent to adopt the currently effective interconnection agreement between Windstream Kentucky East, LLC ("Windstream") and Insight Phone of Kentucky, LLC.

Big River Telephone is a utility within the meaning of KRS 278.010(3)(e) and is a competitive local exchange carrier or CLEC. Windstream is an incumbent local exchange carrier or ILEC. The referenced agreement, which is to be adopted in its entirety, is identified by the tracking number 00942-AI on the Commission's publicly-available Internet site for approved agreements. The CLEC party to this unexpired agreement is Insight Phone of Kentucky, LLC ("Insight").

The Commission has frequently acknowledged the statutory right of carriers to adopt existing interconnection agreements by notice to the Commission.¹ As the adoption arises from a statutory right, such a request may be reviewed expeditiously and promptly granted.² Moreover, in this case Windstream has acknowledged Big River Telephone's right to adopt the agreement and has agreed that the adoption will be effective on the date this notice is filed. Accordingly, Big River Telephone requests expedited review of this Notice and an Order that:

- Approves Big River Telephone's adoption of the existing interconnection agreement between Windstream and Insight filed with the Commission on March 18, 2008 (the "Insight ICA"); and
- Directs Windstream to file the agreement adopted by Big River
 Telephone.

PARTIES

1. Big River Telephone is a Missouri limited liability company, whose principal place of business is 24 South Minnesota, Cape Girardeau, MO 63702-1608.

- 3. Windstream is an incumbent local exchange company ("ILEC") as defined under Section 251(h) of the Act, and is authorized to provide telecommunications services in the Commonwealth of Kentucky.

BACKGROUND

- 5. A true and correct copy of the current Insight ICA, as amended, can be viewed on the Commission's website³: http://162.114.3.165/PSCICA/0000/00942/
- 6. Big River Telephone intends to be bound by the terms of the unexpired agreement, anticipating that the terms of the agreement will be reproduced in their entirety, substituting Big River Telephone in the place of Insight in the Agreement.
- 7. By correspondence to Windstream's counsel dated September 16, 2009 Big River Telephone notified Windstream in writing that Big River Telephone intended to exercise its statutory right to adopt the Insight ICA. On September 17, 2009, Scott A. Terry of Windstream acknowledged that the agreement would be adopted by Big River Telephone.
- 8. Big River Telephone's notice is made pursuant to Section 252(i) of the Act and the FCC's interconnection adoption regulation at 47 C.F.R. § 51.809.
- 9. Big River Telephone does not believe that there are any material issues of fact in dispute that the Commission needs to address at this time to grant the relief requested on the basis asserted in this Notice.

PRAYER FOR RELIEF

WHEREFORE, Big River Telephone requests that the Commission issue its Order:

Acknowledging Big River Telephone's adoption of the existing
 interconnection agreement between Windstream and Insight filed March
 18, 2008.

- b) Requiring Windstream to file with the Commission a true and complete copy of the approved agreement; and
- c) Granting such other and further relief as the Commission deems just and proper.
