## ORDER

On September 17, 2009, Big River Telephone Company, LLC ("Big River") filed notice of its intent to adopt the currently effective interconnection agreement between Windstream Kentucky East, LLC ("Windstream") and Insight Phone of Kentucky, LLC ("Insight"). The unexpired Windstream-Insight agreement was filed with the Commission on March 18, 2008 and identified by Commission tracking number 00942-AI.

Having reviewed the notice by Big River and having reviewed 47 U.S.C. § 251(i), which is the portion of the 1996 Telecommunications Act applicable to this matter, the Commission finds that Big River is entitled to adopt the unexpired Windstream-Insight agreement.

The Commission, having been otherwise sufficiently advised, HEREBY ORDERS that:

1. Big River's request to adopt the existing Windstream-Insight agreement is approved and is effective as of September 17, 2009, the date upon which Big River filed its notice of intent to adopt with the Commission.

- 2. Windstream shall file with the Commission and serve upon Big River and its counsel a true and correct copy of the adopted agreement within 10 days of the date of this Order.
