

RESPONSE TO COMMISSION'S APRIL 6, 2010 ORDER


Comes the Estate of John Ford, and Charles V. Gribbons, Executor of the Estate of John Ford, by Counsel and states as follows:

It is the belief of Charles Gribbons that the Woodland Acres facility is now, and has been for a considerable time being adequately maintained by Mr Joseph Murphy with the approval of interested government authorities and that it is Mr Murphy's desire to continue running and maintaining the facility. It is also the belief of Charles Gribbons that the Big Valley Facility is being maintained under the supervision of Bullitt County Authorities.

The undersigned respectfully submits to this Honorable Commission, that testimony from Mr Joseph Murphy and the appropriate Bullitt County authorities would be helpful to it in rendering its final decision and that if they are not already summoned as witnesses to the scheduled hearing, that they should be so summoned.
