ORDER

On April 2, 2009, in Case No. 2008-00156, the Commission approved the Gas Cost Adjustment ("GCA") clause of Auxier Road Gas Company, Inc. ("Auxier") allowing for the monthly adjustment of its rates.¹

On October 1, 2009, Auxier filed its proposed GCA to be effective November 1, 2009.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

- Auxier's notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.
- 2. Auxier's notice sets out an Expected Gas Cost ("EGC") of \$6.8584 per Mcf, which is an increase of \$1.1360 per Mcf from its prior EGC of \$5.7224 per Mcf.
 - 3. Auxier's notice sets out no current Refund Adjustment.
- 4. Auxier's notice sets out a current month Actual Adjustment ("AA") of (\$.10072) per Mcf to return over-collections of gas cost from August 2009. Auxier's total AA is (\$2.4217) per Mcf, which is a decrease of \$.1477 per Mcf from its previous total

AA of (\$2.2740) per Mcf. Due to a mathematical error, the previous total AA did not include the previous quarter AA of (\$.0470). This error will be corrected in Auxier's next monthly filing when sales for September are known.

- 5. Auxier's notice sets out no current quarter Balance Adjustment ("BA"). Auxier will not need to calculate a BA until its February 1, 2010 filing for rates effective March 2010. The total BA of \$.0068 per Mcf represents no change from the previous total BA.
- 6. Auxier's Gas Cost Recovery rate is \$4.4435 per Mcf, which is an increase of \$.9883 per Mcf from its previous rate of \$3.4552 per Mcf.
- 7. The rates in the Appendix to this Order are fair, just and reasonable, and should be approved for billing for service rendered by Auxier on and after November 1, 2009.

IT IS THEREFORE ORDERED that:

- 1. The rates in the Appendix attached hereto and incorporated herein are approved for billing for service rendered on and after November 1, 2009.
- 2. Within 20 days of the date of this Order, Auxier shall file with this Commission its revised tariff sheets setting out the rates approved herein.
