Informal Conference of November 19, 2009

On November 19, 2009, Commission Staff held an informal conference to update the status of discussions between the City of Greensburg and Green-Taylor Water District regarding the proposed rate. The sign-in sheet attached to this memorandum reflects the participants of the informal conference.

The parties stated that the water district and its consultants were meeting with the city's auditor and reviewing the city's finances to determine whether the proposed rate is reasonable. Staff stated that it typically issues a detailed data request at the beginning of municipal rate cases, but that it would be willing to wait a few weeks for the parties to determine whether an agreement on the proposed rate would be likely. Greensburg's Mayor Cheatham stated that the city would prefer to have the data request issued immediately to ensure that the PSC proceedings are not delayed. Commission Staff stated that it would issue the data request in the near future and request that the Commission set up a procedural schedule for the case.

The conference then adjourned.
