Informal Conference Memorandum

An informal conference ("IC") was held in this matter on Thursday, February 4, 2010. A copy of the conference attendance list is attached. The purpose of the IC was to discuss the potential hearing dates for this proceeding.

During the course of the IC, Counsel for the parties and Commission Staff discussed the following issues:

- Counsel for the parties stated that the Joint Procedural Schedule, which was adopted by the Commission through an Order issued on January 25, 2010, is sufficient and no changes are required at this time.
- Counsel and Commission Staff outlined 3 sets of potential hearing dates. Counsel stated that they will need to consult with their parties and witnesses to confirm their availability on those dates. Commission Staff stated that they would talk with counsel the week of February 8, 2010 to confirm that the following dates are acceptable and can be presented to the Commission for final selection of a hearing date. The potential dates are:

July 27 and 28, 2010  
August 3 and 4, 2010  
August 10 and 11, 2010

The informal conference then adjourned.
