O R D E R


This matter arises upon the motion filed February 4, 2010 by Community Action Kentucky, Inc. ("CAK") for full intervention. It appears to the Commission that CAK provides a variety of conservation and assistance services for low income households in the service territory of Kentucky Power Company and that such intervention is likely to present issues and develop facts that will assist the Commission in fully considering the matter without unduly complicating or disrupting the proceedings. The Commission also recognizes that a procedural schedule was established in this proceeding by Order dated January 27, 2010. The Commission, being otherwise sufficiently advised, finds that CAK should be granted full rights of a party in this proceeding and should accept the procedural schedule as it now stands.

IT IS HEREBY ORDERED that:

1. The motion of CAK to intervene is granted, and CAK shall accept the existing procedural schedule.
2. CAK shall be entitled to the full rights of a party and shall be served with the Commission's Orders and with filed testimony, exhibits, pleadings, correspondence, and all other documents submitted by parties after the date of this Order.

3. Should CAK file documents of any kind with the Commission in the course of these proceedings, CAK shall also serve a copy of said documents on all other parties of record.
