ORDER

On May 31, 1996, in Case No. 1994-00433, the Commission approved rates for Bluegrass Gas Sales, Inc. ("Bluegrass") and provided for their further adjustment on a quarterly basis in accordance with Bluegrass's Gas Cost Adjustment ("GCA") clause.¹

On November 30, 2009, Bluegrass filed its proposed GCA to be effective January 1, 2010.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

- 1. Bluegrass's notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.
- 2. Bluegrass's notice sets out an Expected Gas Cost ("EGC") of \$6.8121 per Mcf, which is an increase of \$.4374 per Mcf from its previous EGC of \$6.3747 per Mcf.
 - 3. Bluegrass's notice sets out no current quarter Refund Adjustment.
- 4. Bluegrass's notice sets out a current quarter Actual Adjustment ("AA") of (\$.0697) per Mcf. Bluegrass's total AA is (\$3.6916) per Mcf, which is an increase of \$.2411 per Mcf from its previous total AA of (\$3.9327) per Mcf.

- 5. Bluegrass's notice sets out a current quarter Balance Adjustment ("BA") of (\$.0210) per Mcf. In calculating its current quarter BA, Bluegrass did not use the AA or BA which expired September 30, 2009. Correcting for this produces a current quarter BA of (\$.0125) per Mcf. Bluegrass's total approved BA is (\$.0808) per Mcf, which is a decrease of \$.0239 per Mcf from its previous total BA of (\$.0569) per Mcf.
- 6. Bluegrass's GCA is \$3.0397 per Mcf, which is an increase of \$.6546 per Mcf from its previous rate of \$2.3851 per Mcf.
- 7. The rates in the Appendix to this Order are fair, just, and reasonable, and should be approved for billing for service rendered by Bluegrass on and after January 1, 2010.

IT IS THEREFORE ORDERED that:

- 1. Bluegrass's proposed rates are denied.
- 2. The rates in the Appendix attached hereto and incorporated herein are approved for billing for service rendered on and after January 1, 2010.
- 3. Within 20 days of the date of this Order, Bluegrass shall file with the Commission its revised tariffs setting out the rates approved herein.
