ORDER

On December 1, 2009, Garrard County Water Association ("Garrard Water") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹

The Commission, having reviewed the record and being sufficiently advised, finds that:

- 1. Garrard Water purchases water from the City of Lancaster ("Lancaster"), the City of Danville Water Dept. ("Danville") and the City of Berea ("Berea").
- 2. Lancaster increased its wholesale water rate from \$1.97 per 1,000 gallons to \$1.99 per 1,000 gallons on November 20, 2009 per Commission Order in Case No. 2009-00230.² Garrard Water proposes to increase the water rates to its customers effective December 10, 2009 to recover the actual costs of water purchased from Lancaster.

3. During the 12 months ending November 30, 2009, Garrard Water purchased a total of 256,549,054 gallons of water from Lancaster, a total of 81,400,269 gallons of water from Danville, and a total of 24,271,104 gallons of water from Berea and sold a total of 299,790,466 gallons of water. The increase in the cost of purchased water is \$5,130.98, resulting in a purchased water adjustment of \$0.02 per 1,000 gallons.

4. A purchased water adjustment of \$0.02 per 1,000 gallons is fair, just, and reasonable.

IT IS THEREFORE ORDERED that:

- 1. Garrard Water's proposed rates are approved.
- 2. The purchased water adjustment increase of \$0.02 per 1,000 gallons as calculated in Appendix A is approved and the rates in Appendix B, attached hereto and incorporated herein, are fair, just, and reasonable and are approved for services rendered on and after December 10, 2009.
 - 3. The tariff sheets filed by Garrard Water in the application are approved.
