O R D E R

On January 11, 2010, Todd County Water District ("Todd County") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹

The Commission, having reviewed the record and being sufficiently advised, finds that:

1. Todd County purchases water from the Logan Todd Regional Water Commission ("Logan Todd").

2. Logan Todd notified Todd County that, effective March 1, 2010, Logan Todd's wholesale water rate to Todd County would increase from \$3.31 per 1,000 gallons to \$3.75 per 1,000 gallons. Todd County proposes to increase the water rates to its customers effective March 1, 2010.

3. During the 12 months ending October 31, 2009, Todd County purchased a total of 205,883,000 gallons of water and sold 157,887,235 gallons. The increase in the cost of purchased water is \$90,588.52, resulting in a purchased water adjustment of \$0.57 per 1,000 gallons.

4. The rates proposed by Todd County should be approved.

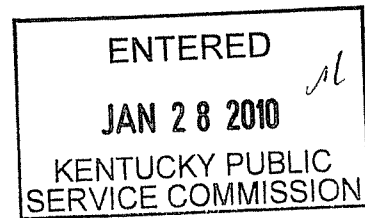

5. The purchased water adjustment of \$0.57 per 1,000 gallons is fair, just, and reasonable and should be approved.


IT IS THEREFORE ORDERED that:

1. The proposed rates by Todd County are approved.
2. The purchased water adjustment of \$0.57 per 1,000 gallons, as calculated in Appendix A, is approved.
3. The rates in Appendix B are fair, just, and reasonable and are approved for services on or after March 1, 2010.
4. The tariff sheets filed by Todd County are approved as filed.
