Pursuant to motions filed by Kentucky Utilities Company and Louisville Gas and Electric Company, the Commission held an informal conference ("IC") at its offices on June 2 and 3, 2010. The IC was held for the purpose of allowing the parties to these cases to discuss and potentially resolve all pending issues in the two cases. A list of attendees at the IC is attached hereto.

The IC led all parties, except the Attorney General of the Commonwealth of Kentucky, to enter into and file a Stipulation and recommendation ("Stipulation") with the Commission on June 8, 2010.
