FIRST DATA REQUEST OF COMMISSION STAFF
TO THE KENTUCKY SCHOOL BOARDS ASSOCIATION

The Kentucky School Boards Association ("KSBA"), pursuant to 807 KAR 5:001, is to file with the Commission the original and 10 copies of the following information, with a copy to all parties of record. The information requested herein is due no later than May 19, 2010. Responses to requests for information shall be appropriately bound, tabbed and indexed. Each response shall include the name of the witness responsible for responding to questions related to the information provided.

Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or the person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

KSBA shall make timely amendment to any prior response if it obtains information which indicates that the response was incorrect when made or, though correct when made, is now incorrect in any material respect. For any request to which KSBA fails or refuses to furnish all or part of the requested information, it shall provide a

written explanation of the specific grounds for its failure to completely and precisely respond.

Careful attention shall be given to copied material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request. When applicable, the requested information shall be separately provided for total company operations and jurisdictional operations.

1. Refer to the Direct Testimony of Charles D. Buechel ("Buechel Testimony"), page 5. Starting at line 3, Mr. Buechel states, "KSBA has discovered that the appropriate tariff has not always been utilized."


a. Is it Mr. Buechel's testimony that schools served by Louisville Gas and Electric Company are not receiving service under the appropriate tariff?

b. If yes, provide details of instances where the appropriate tariff has not been utilized for school boards' facilities.

2. Refer to pages 3 and 5 of the Buechel Testimony where Mr. Buechel states that the Commission has historically used a gradual approach to implement rate increases and recommends that it do so in this case. However, specific recommendations are not provided. If Mr. Buechel has specific recommendations, provide them.
