O R D E R

On September 28, 2010, Louisville Gas and Electric Company (“LG&E”) filed a motion requesting the Commission to correct the rates and descriptions of certain lights listed on Schedule RLS – Restricted Lighting Service in Appendix B to the July 30, 2010 Order in this case. That Order granted LG&E authority to adjust its electric and gas base rates and required that new tariff sheets be filed to reflect the new rates. The new rates and the description of the lights in Appendix B to that Order mirrored those filed by LG&E on June 8, 2010 as Exhibit 5 to its Stipulation and Recommendation.

LG&E states that it filed new tariff sheets as directed, but that there were three separate errors in the rates and description of lights contained in Exhibit 5 to its Stipulation and Recommendation. LG&E further states that the rates and description of lights were correctly listed in Exhibit 2 to its Stipulation and Recommendation. The three errors include: 1) the High Pressure Sodium Vapor lights incorrectly listed as “250 Watt on State of Ky. Pole” when it should have been listed as “250 Watt (metal pole)”; 2) the High Pressure Sodium Vapor light being incorrectly listed as “400 Watt on State of Ky. Pole” when it should have been listed as “400 Watt (metal pole)”; and 3) the omission of the 250 Watt on State of Ky. Pole from Exhibit 5. The three errors appear on LG&E’s

revised Original Sheet No. 36.3, and LG&E filed with its motion as Exhibit C a revised Original Sheet No. 36.3 reflecting the correct rates and descriptions.

Based on the motion and a review of Exhibits 2 and 5 to LG&E's June 8, 2010 Stipulation and Recommendation, the Commission finds that Schedule RLS in Appendix B to the July 30, 2010 Order should be corrected as discussed above and as reflected in LG&E's revised Original Sheet No. 36.3, attached as Exhibit C to LG&E's motion.

IT IS THEREFORE ORDERED that:

1. The July 30, 2010 Order, Appendix B, Page 8, is amended to reflect the following monthly per-unit rates for High Pressure Sodium Vapor lights on the specific poles referenced herein:

250 Watt on State of Ky. Pole	\$ 22.05	\$ 22.05
400 Watt (metal pole)	\$ 27.18	\$ 27.18

2. The revised Original Sheet No. 36.3, attached to LG&E's motion as Exhibit C, is approved as filed.

3. All other provisions of the July 30, 2010 Order shall remain in full force and effect.

4. Within 20 days of the date of this Order, LG&E shall file with this Commission its revised tariffs setting out the rates authorized herein and reflecting that they were approved pursuant to this Order.
