NOTICE TO THE CUSTOMERS OF OLDHAM WOODS SANITATION, INC

On November 5, 2010, Oldham Woods Sanitation, Inc. applied to the Kentucky Public Service Commission ("PSC") for authority to adjust its monthly rate from \$20.00 to \$35.00. After performing a review of the application and records of Oldham Woods Sanitation, the PSC Staff has recommended to the PSC that the requested increase in the monthly rate be approved. The PSC Staff also reported to the PSC that PSC Staff's review indicated that Oldham Woods Sanitation's current operations supported a monthly rate of \$36.05. Pursuant to the PSC's Order of July 7, 2011, Oldham Woods Sanitation has requested that the PSC approve the higher rate of \$36.05 per month for sewer service. Oldham Woods Sanitation, Inc. has filed an application with the Public Service Commission proposing to increase its monthly sewer rate from \$20.00 to \$35.00. Oldham Woods believes it could justify a higher rate, but has reduced the amount of its proposed increase to reduce the potential burden upon its customers. The proposed effective date of the change is <u>December 20, 2010</u>.
