Dear Mr. Armstrong:

The Woodford County Fiscal Court received Notice of Proposal to construct a wireless telecommunications facility in Woodford County on a parcel of land located at 3950 Lexington Road, Versailles, Kentucky from Todd R. Briggs, Esq., Briggs Law Office, PSC, counsel for New Cingular Wireless PCS, LLC.

Pursuant to this notice of proposal, the Commission has received application from New Cingular Wireless PCS, LLC for a Certificate of Public Convenience and Necessity under Case No. 2010-00015 to construct and operate a new wireless telecommunications facility whereby a 195 foot monopole tower and related ground facilities is petitioned for construction.

As Woodford County Magistrate of District No. 7, I, James E. Staples, have several questions related to this proposed wireless telecommunications facility such as: (1) could a commercial project of this magnitude be proposed and granted without a required zone change; (2) would a study of this project be performed to substantiate the effect this wireless telecommunications facility would have on nearby residential subdivisions and subsequent ownership; and (3) would the adjacent property owners and citizens of Woodford County be assured the occasional maintenance responsibilities are factored in as a contractual obligation.

Please be advised that the Woodford County Fiscal Court, as well as my constituents located in District No. 7, emphatically request an intervention by the Commission. Additionally, a public hearing is requested to be held with the appropriate personnel in attendance from the Kentucky Public Service Commission prior to the Certificate of Public Convenience and Necessity being granted to New Cingular Wireless PCS, LLC.




