### **JOINT STATUS REPORT**

BellSouth Telecommunications, Inc., d/b/a AT&T Southeast, d/b/a AT&T Kentucky ("AT&T"), and BLC Management LLC d/b/a Angles Communications Solutions ("Angles"), Budget Prepay, Inc. d/b/a Budget Phone ("Budget Phone"), LifeConnex Telecom, LLC f/k/a Swiftel LLC ("LifeConnex"), and dPi Teleconnect, LLC ("dPi") file this joint status report in accordance with the Joint Motion on Procedural Schedule the Parties filed June 17, 2010, in which the Parties proposed to submit a progress report to this Commission by November 1, 2010. The Commission approved this Joint Motion in its July 14, 2010 Order.

In that Order, the Commission granted the Parties' motion to hold the abovecaptioned matters in abeyance pending the resolution of similar cases pending in other states (Louisiana, South Carolina, North Carolina and Alabama).

In accordance with the procedural schedules adopted in the cases in those other states, the Parties have filed both Direct and Rebuttal Testimony on August 27, 2010 and October 1, 2010, respectively. The Parties are also continuing to work together to schedule hearings in North Carolina and Alabama.
