ORDER

On January 26, 2010, Bracken County Water District ("Bracken District") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹

The Commission, having reviewed the record and being sufficiently advised, finds that:

- 1. Bracken District purchases water from the Augusta Regional Treatment Plant ("Augusta").
- 2. Augusta notified Bracken District that it would increase its wholesale water rates effective January 8, 2010. Augusta's wholesale water rate to Bracken District would increase from \$1.50 per 1,000 gallons to \$1.56 per 1,000 gallons. Bracken District proposes to increase the water rates to its customers effective January 8, 2010.
- 3. During the 12 months ending November 30, 2009, Bracken District purchased a total of 177,185,500 gallons of water from Augusta and sold a total of 159,299,600 gallons of water. The increase in the cost of purchased water is \$10,631.13, resulting in a purchased water adjustment of \$0.07 per 1,000 gallons.

4. A purchased water adjustment of \$0.07 per 1,000 gallons is fair, just, and reasonable.

IT IS HEREBY ORDERED that:

- 1. Bracken District's proposed rates are approved.
- 2. The purchased water adjustment increase of \$0.07 per 1,000 gallons as calculated in Appendix A is approved and the rates in Appendix B, attached hereto and incorporated herein, are fair, just, and reasonable and are approved for services rendered on and after January 8, 2010.
- 3. Within 20 days of the date of this Order, Bracken District shall file a revised tariff reflecting the rates approved herein.
