REQUEST FOR REHEARING

WE, the undersigned parties, do hereby request a rehearing of the decision of the Public Service Commission denying our demand for the Fleming County Water Association to provide an extension of water service by and through an existing water main. We request that we be provided the opportunity to submit additional evidence relating to the following issues:

- 1. Expert testimony and opinion as to the specific measurements and requirements of providing water service to our residence and property by and through an existing water main, including amount of water usage and costs which FCWA would likely incur in providing said service.
- 2. Testimony as to the fact that no other route is currently available to provide water service to our property.
- 3. Testimony from persons who intend to build on this property and also use this exising water main for water service if available.
- 4. Testimony and evidence of livestock on our property which will use water on a regular basis as well as specific information on a Bluegrass Festival to take place on our property.
- 5. Evidence as to the precise distance from a cut off valve to the location we request a water meter be installed.

For all of the foregoing reasons we request the Commission to grant us a rehearing in this matter and a reasonable extension of time, thirty to sixty days, in order to prepare for submission of additional evidence and testimony.
