Informal Conference Memorandum

An informal conference ("IC") was held in this matter on Thursday, May 20, 2010. A copy of the conference attendance list is attached. The purpose of the IC was to discuss the status of the parties' negotiations on the consolidation of the cases and narrowing the DPLs that have been submitted to the Commission.

During the course of the IC, the parties stated that they agree additional time is needed for negotiations. The parties stated that, to date, negotiations have been very fruitful and productive and have resulted in the resolution of some issues. AT&T requested that the parties have another 30 days for continued negotiations. Sprint suggested that another IC be held the week of June 14, 2010 for a discussion of a status update. Commission Staff stated that it had no objections to allowing the parties to continue negotiations if they are productive. Commission Staff scheduled the date for the next IC as Thursday, June 24, 2010 at 3:00 p.m., Eastern Time.

The informal conference then adjourned.
