ORDER

On March 5, 2010, Big Sandy Water District ("Big Sandy") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹

The Commission, having reviewed the record and being sufficiently advised, finds that:

- 1. Big Sandy purchases water from the City of Louisa ("Louisa"), City of Kenova, West Virginia ("Kenova"), Rattlesnake Ridge Water District ("Rattlesnake Ridge"), and Cannonsburg Water District ("Cannonsburg").
- 2. Cannonsburg notified Big Sandy that, effective March 15, 2010, its wholesale rate to Big Sandy would increase from \$2.32 per 1,000 gallons to \$2.50 per 1,000 gallons.
- 3. Big Sandy proposed a purchased water adjustment factor of \$0.04 per 1,000 gallons.
 - 4. Big Sandy proposed an effective date of March 15, 2010.

5. During the 12 months ending January 31, 2010, Big Sandy purchased 78,601,000 gallons of water from Louisa, 232,999,000 gallons from Kenova, 4,506,640 gallons from Rattlesnake Ridge, and 54,447,800 gallons from Cannonsburg, and it sold 275,849,800 gallons. The increase in the cost of purchased water is \$9,800.60, resulting in a purchased water adjustment factor of \$0.04 per 1,000 gallons.

6. The purchased water adjustment factor of \$0.04 per 1,000 gallons is fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:

- 1. The rates proposed by Big Sandy are approved.
- 2. The purchased water adjustment factor of \$0.04 per 1,000 gallons as calculated in Appendix A is approved.
- 3. The rates in Appendix B, attached hereto and incorporated herein, are fair, just, and reasonable and are approved for services on or after March 15, 2010.
 - 4. The revised tariff sheets filed by Big Sandy are approved as filed.
